

**TERMS AND CONDITIONS FOR EXHIBITORS / VENDORS
PRIDE FEST 2010 PARK FESTIVAL**

Please read the following and sign below to indicate your agreement to abide by and follow the terms and conditions listed herein.

Mobile Alabama Pride, Inc. (MAP) presents Pride Fest 2010, "ONE HEART, ONE WORLD, ONE PRIDE" for the public and reserves all rights as producers. Any reproduction, rebroadcast or commercial use of any portion of the event, in whole or part, in any form, without permission of MAP is strictly prohibited.

1. Applicants understand the purpose of Mobile Alabama Pride, Inc. Pride Fest 2010 is to celebrate gay, lesbian, bisexual and transgender Pride, and agrees to do nothing to defeat this purpose during the term of this license to occupy.
2. Exhibitors / Vendors shall submit the required entry form with the appropriate non-refundable fee.
3. Exhibitors / Vendors should be ready for viewing by 11:00 a.m. and remain until the closing at 6:00 p.m.
4. All businesses and other activity for which the Exhibitor / Vendor has rented space must be conducted within the designated booth space ONLY. One tent ONLY per rented 10'x10' space, additional charges will be applied if there is more than one tent
5. Tents, chairs, tables, lights, etc. will be supplied by Exhibitor / Vendor.
6. No sale of alcoholic beverages.
7. Exhibitors / Vendors must post prices legibly and visible to the general public at all times.
8. Non-Profit Rates: If you are an organization which qualifies as a non-profit organization, please submit a photocopy of your IRS Letter of Determination with the application.
9. Exhibitors /Vendors understand that MAP has legal possession and control of Bienville Square pursuant to agreement with the City of Mobile Parks and Recreation Department. MAP reserves the right to terminate this license to occupy at any time if MAP determines the Exhibitor / Vendor has created a nuisance to any other applicant, if the Exhibitor / Vendor has falsified any information on the application, or if the Exhibitor / Vendor has violated any government laws or ordinances.

Mobile Alabama Pride, Inc. reserves the right to place Exhibitors / Vendors on the Festival Grounds according to the master plan, and is done on a first-come, first-serve basis.
